#### Note 1 Statement of Accounting Policies

#### a Reporting Entity

The Financial statements presented here are for The Otago Goldfields Heritage Trust Incorporated (OGHT). The OGHT was registered as an incorporated society under the Incorporated Society's Act 1908 on 25 July 1989 and subsequently registered under The Charities Commission on 13 May 2008.

The Financial Statements are a special purpose report prepared for the requirement of the members

#### b General Accounting Principals

The measurement basis of historical cost has been adopted. The financial statements have been prepared on a going concern basis and accrual accounting is used to match revenues and expenses

#### c Particular Accounting Policies

Particular accounting policies, which materially affect the measurement of statement of income and expenses and balance sheet, have been applied as follows:

#### Income

Income is recorded when received

#### Investments

Investments have been valued at cost

#### **Goods and Services Tax**

The financial statements have been prepared on a GST exclusive basis

#### **Depreciation**

Depreciation has been calculated and based on rates approved by Inland Revenue Department for tax purposes

#### **Fixed Assets**

Fixed Assets are stated at cost less accumulated depreciation

#### Taxation

The OGHT is registered with the Charities Commission and meets the Inland Revenue Department requirements for exemption from income tax.

#### **Donated Goods and Services**

In common with similar organisations, the OGHT receives donated goods and services. The impact of this is not disclosed in the financial statements because it is difficult to quantify and not considered material. Examples of donated goods and services include "working bees".

#### **Capital Commitments & Contingent Liabilities**

The society has a grant approved from Central Lakes Trust for the purchase of a Heritage Phone app, however the app developer to date has not provided what was agreed. The grant was not drawndown in full and after negotiations a final settlement has been made.
